The Moneychangers - 4 Conspiracy

Something is Wrong

A Georgetown University professor, Carroll Quigley, wrote the following in his history of the world, *Tragedy and Hope*:

*[T]he powers of **financial capitalism** had another far-reaching aim, nothing less than to create a **world system of financial control** in private hands able to **dominate the political system** of each country and the economy of the world as a whole. This system was to be controlled in a **feudalist** fashion by the **central banks** of the world acting in concert, by **secret agreements***

*arrived at in frequent private meetings and conferences.*¹

This quote from a prominent historian and teacher should be kept in mind as you read this article.

In his book, professor Quigley described a secret organization of influential men and groups so arranged with an inner and outer circle. Professor Quigley related that he had studied and had been permitted to examine the records of this organization and generally agreed with their goals.²

This is the situation facing the world and our nation today. The problem is that most people cannot accept the reality of it. Somehow they relate questioning the intentions of their government as

being unpatriotic. This is not the case, since it should be patriotic to promote moral principles and laws while upholding the Constitution, and insisting that our government do the same. It is not patriotic to allow our government to follow the dictates of special interests over the common welfare of its citizens.

People fail to understand that they have been slowly programmed and manipulated to accept what they are told by their leaders, schools, and media. They have been programmed to accept the beliefs of a worldview alien to the belief system of our founders, and totally at odds with our Constitution. This has not happened suddenly; it has been a slow process of influence that has taken place over many years so that it has been almost imperceptible. This is why that nothing seems to change, other than the methods employed, whether or not the Republicans or the Democrats gain control of the government. The goals are the same for both parties – eventual one-world government. The reason is that, as will become apparent, they are controlled and influenced by the same people – the moneychangers. As a nation, we must cast off these alien beliefs, hold our leaders accountable, and elect moral leaders, perhaps even leaders independent of the two political parties.

This conspiracy in our land is not recent. It goes well beyond the founding of our nation. It has infected people in the highest positions of our government. It is in fact ancient in origin.

Conspiracy – Historical Background

Biblical – The Fall

There is a conspiratorial theme that runs through the Bible with its roots firmly fixed in the events of Genesis chapter 3. This conspiracy involves God's creatures in rebellion against their Creator. In Genesis chapter 3 we are first introduced to the adversary of God and man in the form of a beguiling serpent. The key to understanding the nature of this conspiracy is found in Genesis 3:15 where we are told:

And I will put **enmity between thee and the woman, and between thy seed and her seed**; it shall bruise thy head, and thou shalt bruise his heel. **Genesis 3:15**

This single verse, the very first prophecy of the Bible, is the key to unlocking the mystery of our salvation. It speaks of the cosmic battle that rages throughout

Scripture. It promises that God would provide a virgin-born Savior in the form of His Son to redeem fallen mankind from the curse of his rebellion. God even predicted that His Son would be bruised in this conflict while defeating the adversary known as Satan.

Another key to unlocking the mystery of this conspiracy is another verse of Genesis chapter 3:

Unto Adam also and to his wife did **the Lord God make coats of skins, and clothed them**. **Genesis 3:21**

This verse speaks of another thread that runs throughout Scripture – that of atonement for sins. The clothing of Adam and Eve represents a temporary covering for sin, as do the sacrifices of Isaac (Genesis 22) and those made in the Temple. These are types (figures) that point to the coming sacrifice that provides a lasting atonement in the crucifixion of God's Son on the cross. This thread points toward the ultimate defeat of the original conspiracy. This is made clear by the writer of Hebrews:

For Christ is not entered into the holy places made with hands, **which are the figures of the true**; but into heaven itself, now to appear in the presence of God for us: **Nor yet that he should offer himself often**, as the high priest entereth into the holy place every year with blood of others; For then must he often have suffered since the foundation of the world: but now **once in the end of the world hath he appeared to put away sin by the sacrifice of himself**. And as it is appointed unto men once to die, but after this the judgment: So **Christ was once offered to bear the sins of many**; and unto them that look for him shall he appear the second time without sin unto salvation. **Hebrews 9:24-28**

So we see that the world of mankind began with a conspiracy, and the history of the world being played out has been one of conspiracy after conspiracy. The various conspiracies flourishing in the world are really a part of the vast cosmic battle that has been waging since the serpent of Genesis chapter 3.

Dr. John Coleman has been studying the subject of conspiracy in modern times for nearly 40 years and has revealed in his book, *The Conspirator's Hierarchy: The Committee of 300*, that he soon

realized the religious nature of the conspiracy when he realized that Christianity was the real target.

*The thing that excited me was the common thread between the French and Bolshevik Revolutions: **A common hatred of Christianity**, the major religion of the world.³*

Historian Jonah Goldberg reinforces this conclusion in his book, *Liberal Fascism*, when he notes that:

*Whatever else it may have been, however, one thing is clear: the French Revolution was the first totalitarian revolution, the mother of modern totalitarianism, and the spiritual model for the Italian Fascist, German Nazi, and Russian Communist revolutions. A nationalist-populist uprising, it was led and manipulated by an intellectual vanguard determined to **replace Christianity with a political religion** that glorified “the people,” anointed the revolutionary vanguard as their priests, and abridged the rights of individuals.⁴*

The history of the world has been the history of conspiracy since Genesis chapter 3, and be assured that that first conspiracy is still in play. That first conspiracy has many branches and forms. We will first look at one branch that has great relevance for our society today. It is a branch of the conspiracy that is perpetrated on the world by the moneychangers. This particular branch had its beginnings in India.

Secular – The East India Company

The East India Company had its beginnings in 1600 with a charter from Queen Elizabeth I. From this period of time, the East India Company cultivated relations with the princes and bankers of India, and for the first time, learning the secrets of what is known as “fractional reserve banking.” This is the system of banking that is the basis for our current monetary system as practiced by the world’s central banking system and our own Federal Reserve Banks.⁵

We have described “fractional reserve banking” in great detail in our previous issue, *The Moneychangers – 1*, available on our website www.creationrevelation.org. Simply put, it is the practice of creating more money than the value of assets deposited on the assumption that the deposited assets will not be required by all of the depositors at the same time. It is an inflation of the money supply by the banks allowing them to charge interest on money that they created from nothing without backing. This practice results in a hidden

tax on the citizen by way of confiscation of personal wealth through inflation.

This is the same system that the House of Rothschild used to establish their great wealth and power. It is this power that has enabled the moneychangers to enslave the world’s political systems.

The vast wealth and power of the élite moneychanger families was substantially increased by the opium trade acquired by the expansion of the East India Company and their associated European and American families throughout the Far East and China during the colonial period.⁶ It was the House of Sassoon, opium traders from Baghdad, which became affiliated through marriage (since 1881) with the English and European branches of the House of Rothschild. The Sassoons owned banks in China and Japan.⁷

These moneychangers maintain their control of the world by secret organizations in order to maintain their power and influence without alarming the people of the nations they control.

The Illuminati

Most of what we know of the organization called the Illuminati comes from two books, *Proofs of a Conspiracy* and *Memoirs Illustrating the History of Jacobinism*, both written in the late 1700s. None other than George Washington acknowledged in writing his belief that this conspiracy existed and some members may have infiltrated some Masonic Lodges of our nation.⁸ The founder of this organization was Adam Weishaupt.

Adam Weishaupt, born in Bavaria in 1748, became a professor of Canon Law at the University of Ingolstadt.⁹ He became obsessed by his hatred of God toward the overthrow of “every religion, every government, and all property whatsoever.” This obsession led him to believe that he could convince the world to follow these ideas.¹⁰

Adam Weishaupt wrote these words on 1 May 1776:

*Behold our secret: If in order to **destroy Christianity**, all religion, we have pretended to have the sole true religion, remember that the end justifies the means, and the wise ought to take all the means to do good which the wicked take to do evil. This can be done in no other way but by **secret associations**, which will by degrees, and in silence, possess themselves of the government of the States, and make use of these means for this purpose, which the wicked use for*

*obtaining base ends. The express aim of this order was to abolish Christianity, and overthrow all civil government.*¹¹

On 1 May 1776, his new Order of Illuminees, or the Illuminati, was founded. Weishaupt began at first to initiate students at his university. This was the same organization that under the name “Jacobin” fomented the French Revolution.¹² The modern equivalent of Jacobinism is Bolshevism.¹³

The thinking of Weishaupt, as with the pure Communist, is that the inequities of the world, where some have and some have not, are based on the ownership of property. If one were able to abolish property ownership and redistribute the wealth, or have everything held in common, everyone would be able to enjoy the blessing of plenty, and wars and man’s inhumanity to man would cease, or so the theory goes.¹⁴ However, if one were merely to redistribute the wealth equally, it would soon become unequal as men have different capabilities, and ruthless greed and a lust for power drive many. Moreover, an equal distribution would only tend to make everyone equally poor.¹⁵ The solution of the pure Communist is that the wealth is to be held in common with no private ownership allowed.¹⁶

Although the Illuminati were soon exposed and dismantled, many today believe that the organization went underground, and is alive and well in secret societies today. Supposedly, the Illuminati membership under differing names is the driving force for world socialist government. There are no doubts that secret organizations do exist that have as their goal a one-world government. These organizations are made up of the powerful élite, members of the media, and governments of the world.

A World Run by Secret Committees, Corporations, and Bankers

We should ask ourselves the question, what are the goals today of these moneychanger élite?

The Return to Serfdom

The ultimate goal of the moneychangers is a return to feudalism where the world is controlled by élites which make up the ruling class and serfs that comprise the working class. This can be seen today in the control of energy. Cheap energy for everyone is not what is desired. Cheap energy would tend to lift the impoverished Third World masses from their own brand of serfdom and poverty. Cheap energy

would give the Third World the ability to rise from their own poverty and shake off the handouts from groups such as United States foreign aid and the International Monetary Fund (IMF). US handouts through foreign aid opens the door for US corporations to grab resources. The IMF controls much of the third world by loans to governments that keep the masses in check, whose leaders pocket the money for themselves, as the corporate profiteers and the IMF rape the resources for themselves. This is why nuclear energy is anathema to the world planners.¹⁷

The world has been made to fear the spread of nuclear weapons. Iran today is a prime example of this fear, and maybe rightly so. But most are unaware that Iran’s desire for cheap energy, that would bring her self sufficiency and prosperity for her people, began with her plans to acquire nuclear power in 1971. To prevent this, the CIA launched a covert action that resulted in the overthrow of the Shah. Iran was thus forced to remain a feudal nation.¹⁸

Coleman writes that “Nuclear generated energy is *the key* to bringing Third World countries out of their backward state.... To be independent, a nation must be able to control its energy source.” But, he shows that the policy of world planners is one of “zero-growth” in the Third World as directed by the Club of Rome through their spokesman Count Etienne Davignon. This is why the Club of Rome has financially supported the “environmentalist” movement’s war on nuclear power. Greater control of a nation’s energy makes them less dependant on US aid and IMF loans.¹⁹ Less dependence means less profit for the moneychangers.

Another factor that is important to the global planners when denying cheap energy to the Third World is that prosperity gives rise to increases in population. Bertrand Russell called this “useless eaters – surplus population.”²⁰

Foreign aid provides profit for governments and corporations but is financed by the US taxpayer. There are two purposes of foreign aid. First – keeping US taxpayers in a state of involuntary servitude, and therefore less able to oppose the government. Second – keeps a state of dependency by beneficiary nations on the global planners.²¹ In 1964, Emmanuel Josephson wrote in *The Truth about Rockefeller*:

Nelson Rockefeller knew what he was doing when his Foreign Aid bill became law in 1946, since then, it has become one of the most bare-faced thefts of the earnings of the American working people; a racket run by the American government and paid for

by the American people thereby reduced to a state of involuntary servitude, little better than slaves, Nelson Rockefeller attained new and record heights for the Dynasty in the looting of the American taxpayer.²²

We will now look briefly at some of the secret organizations that intend to bring about a new world order under a one world government.

The Committee of 300

Author and historian H. G. Wells wrote of the worldwide conspiracy in his *The Open Conspiracy* as follows:

The political world of the Open Conspiracy must weaken, efface, incorporate and supersede existing governments. The Open Conspiracy is the natural inheritor of socialist and communist euphemisms; it may be in the control of Moscow before it is in the control of New York. The character of the Open Conspiracy will now be plainly displayed. It will be a world religion. This large loose assimilatory mass of groups and societies will definitely and obviously attempt to swallow up the entire population of the world and become a new human community.²³

Certainly we are seeing signs of attempts to blur differences between world religions in the push for ecumenism. Wells had more to say:

The Organization of this that I call the Open Conspiracy, which will ultimately supply teaching coercive and direct public services to the whole world is the immediate task before all people, a planned World State is appearing at a thousand points. When accident (or crisis) finally precipitates it, its coming is likely to happen very quickly. Sometimes I feel that generations of propaganda and education may have to precede it. There must be a common faith and law for mankind....²⁴

In previous newsletters, *The Moneychangers* – 1, 2, and 3 (available on our website), you were introduced to several organizations made up of the élite of the world. These organizations were in the front line of setting the agendas for the world. Nothing happens in the world unless these organizations sanction it. Wars are planned, prices set, governments toppled, and presidents made by the planning of the members of these groups.

Two of these groups were prominently mentioned, the Bilderbergers and the Council on Foreign Relations (CFR) which especially affect the

United States. While these groups hold considerable sway over world planning, these are really the front organizations according to Dr. John Coleman. It is what Coleman calls The Committee of 300 that controls the vast network of organizations and secret societies that actually call the shots. And it is a small group of individuals, the “Olympians,” within the 300 that holds the overriding control.²⁵

Bilderbergers

In *The Moneychangers* – 3 we discussed the Bilderberg Group. The Bilderberg Group was formed in 1954 by Prince Bernhard of the Netherlands. Membership is by invitation, favoring those that believe in their idea of a Fabian-socialist one-world government. Among those so honored are David Rockefeller, Henry Kissinger, and Bill Clinton.

Fabianists believe in “the democratic control of society in all its activities.” They believe that “control of the individual is best achieved through global government, a goal Fabianism shares with Communism.” The term “global governance” is now preferred over “global government,” since the latter term has become readily identifiable as referring to one-world government. The Bilderberg group meets annually in secret.

Council on Foreign Relations (CFR)

The Council on Foreign Relations (CFR) in particular has a controlling influence on the US State Department. Secretary of State Condoleezza Rice, VP Dick Cheney, and the first president Bush have been members, as are most of the high appointments of the State Department, the media that controls the news, and university Presidents. The stated goal of the CFR is a global world government.

The Council on Foreign Relations (CFR) has been the moneychanger’s chief link to the U.S. government since its founding in 1921. The CFR advocates the creation of a world government and is soft on communism and socialism.²⁶ Although most Americans have probably never heard of this organization, the membership reads like a “Who’s Who” of our nation’s leaders, educators, financiers, and members of the media. The media is conspicuous in its silence concerning activities and members of this extremely influential organization. If you examine a list of its members you will understand why they are silent - they all belong to the same club. The CFR virtually controls the U.S. Department of State and the Central Intelligence Agency (CIA) through its membership.²⁷ In addition, the membership of the CFR is filled with members in key areas of influence and control of the media, banking,

education, politics, government, military, and industry.²⁸ The CFR is the American counterpart of the "Round Table Groups" set up by Cecil Rhodes, together with his Rhodes Scholarships to promote the same goals of world federation, especially of an Anglo-American federation.²⁹

The Trilateral Commission

Many of the élite that belong to the CFR also belong to the Trilateral Commission. The Trilateral Commission is an organization founded by David Rockefeller in order to organize the world into three economic zones, European, American, and Asian. Former Republican presidential candidate Senator Barry M. Goldwater in his book, *With No Apologies*, writes concerning the purpose of the Trilateral Commission as follows:

*It is intended to be the vehicle for multinational consolidation of the commercial and banking interests by seizing control of the political government of the United States.*³⁰

President Jimmy Carter was a founding member.³¹ Presidents are made by the moneychangers; they control both parties. The following statement by Goldwater describing how Jimmy Carter became president gives great insight as to how the moneychanger organizations control our government:

*David Rockefeller and Zbigniew Brzezinski found Jimmy Carter to be their ideal candidate. They helped him win the nomination and the presidency. To accomplish this purpose, they mobilized the money power of the Wall Street bankers, the intellectual influence of the academic community – which is subservient to the wealth of the great tax-free foundations – and the media controllers represented in the membership of the CFR and the Trilateral.*³²

Because of the power of these organizations, the voters have very little to say about who becomes president, or who or what they actually represent.

The Club of Rome

And the fourth kingdom [Rome] shall be strong as iron: forasmuch as iron breaketh in pieces and subdueth all things: and as iron that breaketh all these, shall it **break in pieces** and bruise. And whereas thou sawest the feet and toes, part of potters' clay, and part of iron, **the kingdom shall be divided**; but there shall be in it of the

strength of the iron, forasmuch as thou sawest the iron mixed with miry clay. And as **the [ten] toes** of the feet were part of iron, and part of clay, so the kingdom shall be partly strong, and partly broken. And whereas thou sawest iron mixed with miry clay, they shall mingle themselves with the seed of men: but they shall not cleave one to another, even as iron is not mixed with clay. And **in the days of these kings shall the God of heaven set up a kingdom, which shall never be destroyed**: and the kingdom shall not be left to other people, but **it shall break in pieces and consume all these kingdoms, and it shall stand for ever.**
Daniel 2:40-44

This ten part confederacy and its leader are further described by Daniel as follows:

After this I saw in the night visions, and behold a fourth beast [Rome], dreadful and terrible, and strong exceedingly; and it had great iron teeth: it devoured and brake in pieces, and stamped the residue with the feet of it: and it was diverse from all the beasts that were before it; and it had ten horns. I considered the horns, and, behold, **there came up among them another little horn**, before whom there were three of the first horns plucked up by the roots: and, behold, **in this horn were eyes like the eyes of man, and a mouth speaking great [blasphemous] things.** Daniel 7:7, 8

Daniels prophecies speak of Rome, and the revival of Rome in the last days with ten kings. Daniel also prophesies that this Antichrist Roman kingdom will be conquered by Christ with His second coming and the establishment of His millennial kingdom. What is significant here is the prophecy that revived Rome will be a confederacy of ten parts.

The Club of Rome is the crisis management arm of the world planners. They funded and set up the environmental movement. They create crises in order to promote their agendas. A key Club of Rome meeting was held in Washington DC on 10 December 1980 concerning economic plans for destabilizing the U.S. economy.³³ These created crises cause the mass of people to accept their solutions without protest. We will discuss the methods used later.

The Club of Rome has proposed dividing the world into ten regions, each of which would need a

leader or some sort of government head. These regions are in the process of forming. In addition to the political regions, seven economic regions are planned that generally conform to the same regional areas. Region 1 is indicated as North America while region 2 on the Club of Rome map is the current European Union.³⁴ Recently, region 8, the African Union has been mentioned in the news.

We already know of the reality of the European Union (EU) indicated as region 2 on the map, with its common currency, the EURO. What is not so well known are the efforts to bring about a North American Union (NAU) with open borders, unifying Canada, Mexico, and the United States, including a common currency, the AMERO. The NAU is indicated generally as region 1 on the map, but incorporates Mexico in what is initially an economic scheme.³⁵ This could explain why our government is so reluctant to protect our border with Mexico.

Don't forget that the EU was initially an economic scheme that later became a political region. The European Common Market (EC) began as a "free trade" agreement and later evolved into a political union. The genesis of the European Union is similar to our own North American Free Trade Agreement (NAFTA).

North American Union

So he carried me away in the spirit into the wilderness: and I saw a woman sit upon a scarlet coloured beast, full of names of blasphemy, having seven heads and **ten horns**. And the woman was arrayed in purple and scarlet colour, and decked with gold and precious stones and pearls, having a golden cup in her hand full of abominations and filthiness of her fornication....

And there are seven kings: five are fallen, and one is, and the other is not yet come; and when he cometh, he must continue a short space. And the beast that was, and is not, even he is the eighth, and is of the seven, and goeth into perdition. And **the ten horns which thou sawest are ten kings**, which have received no kingdom as yet; but **receive power as kings one hour with the beast**. These have one mind, and shall give their power and strength unto the beast. **These shall make war with the Lamb, and the Lamb shall overcome them:** for he is Lord of lords,

and King of kings: and they that are with him are called, and chosen, and faithful. And he saith unto me, The waters which thou sawest, where the whore sitteth, are peoples, and multitudes, and nations, and tongues. And the **ten horns** which thou sawest upon the beast, these shall hate the whore, and shall make her desolate and naked, and shall eat her flesh, and burn her with fire. For God hath put in their hearts to fulfil his will, and to agree, and give their kingdom unto the beast, until the words of God shall be fulfilled. **Revelation 17:3, 4, 10-17**

NAFTA/CAFTA

Europe has been reassembled into the European Union (EU). With the passage of the NAFTA (North American Free Trade Agreement), together with the formation of the World Trade Organization (WTO), and World Court, two legs (European and American) of this world unity are coming sharply into focus. It remains to bring Asia into sync to realize the goals of the Trilateral Commission.

A recent push to set up an American style EU (European Union in the Americas) as the next step in creating one governing body for the Americas is CAFTA (Central American Free Trade Agreement). Progressively our leaders are pushing toward the ultimate prize of unifying the Americas into an EU type union with the inherent loss of national sovereignty. World government is ultimately the goal – when, at last, all regions of the world are unified in accordance with the ten-region plan of the Club of Rome.

If you doubt that an EU type union is the goal for the Americas, consider that the EU began with a NAFTA type free trade agreement called European Coal and Steel Community (ECSC). The ECSC eventually incrementally morphed into the European Union we see today.³⁶

In 2004 the Council on Foreign Relations created a task force on the future of North America. Then, in March of 2005 they published a report entitled *Creating a North American Community*, setting a date of 2010 for integration of the economies of Canada, United States, and Mexico. They also pushed for open borders between these nations.³⁷

In the early 1990s, through the North American Free Trade Agreement (NAFTA), the U.S. joined with Mexico and Canada in an embryonic political and economic union. CAFTA is the next stage

in the plot to integrate the hemisphere. CAFTA, a forerunner of an "EU of the Americas," trades away American jobs in the name of rewarding Latin American "democracies." CAFTA is described as "a critical steppingstone toward creation of a 34-nation Free Trade Area of the Americas (FTAA), an embryonic regional government modeled after the socialistic European Union." It was "[d]uring a NAFTA summit in Crawford, Texas, President George W. Bush, Canadian Prime Minister Paul Martin and Mexican President Vicente Fox, described CAFTA as a plan to build an EU-style hemispheric political entity." This scheme is perceived by the promoters "to be a form of foreign aid to 'emerging democracies' in Central America – tacitly recognizing that it wouldn't result in genuine free trade, but rather a huge transfer of wealth from the U.S. to the region." The result would be to encourage the export of U.S. manufacturing jobs (we have seen this happen already as a consequence of NAFTA).³⁸

What originally began as a "Partnership for Prosperity" between Mexico, Canada, and the United States in 2001 suddenly became a "Security and Prosperity Partnership (SPP)" after the terrorist attacks on 9/11 of the same year. The agreement now pushed for open borders between the countries, thus extended protected borders to the North American continent itself. The SPP is, in effect, a memorandum of understanding between the nations with no approval sought or obtained from congress. As a working document, the SPP creates the mechanism to establish regulations for the purpose of integration of the security and economic conditions for the three countries. The SPP is rewriting U.S. administrative laws without congressional oversight and creating what might be called a "shadow government" structure. With the collapsing dollar, a new currency, the AMERO, has been proposed that would merge the values of the existing currencies. Driven by the CFR's *Creating a North American Community*, the end result of SPP may well be North American Union.³⁹

As part of the plan to regionalize North America there is a plan to construct a NAFTA superhighway from Mexico through Texas to Canada and Alaska. This would bypass the expensive longshoremens of the U.S. ports of entry in favor of the cheap labor of Mexican entry ports. The Texas portion of the highway is called the Trans-Texas Corridor. Nothing much is reported to the American people by the controlled media concerning this plan. Except for Texans, most of the country remains unaware. The highway project will contain a multilane highway and rail system with fenced in limited access

that will turn many communities into ghost towns along the confiscated right-of-way. The highway system will be under control of a Spanish corporation, and the port of entry will be in Kansas City.⁴⁰

The goal in the Americas is that all currency is to achieve parity. In order to accomplish this, various national economies need to be equalized, through unequal trade agreements such as NAFTA/CAFTA. The Japanese, American, and European economies must be lowered, or crashed to equalize with the least affluent economies. The standard of living in all nations must be equalized in order to meld the nations into a super-state (New World Order; One-World Government). The ultimate goal is a feudalistic world government.

Tax-exempt Foundations

Tax-exempt foundations play their part in moving the nation and the world toward world government. Rene A. Wormser revealed in his book, *Foundations: Their Power and Influence*, that the Congressional "Reese Committee" found that:

*In the international field, foundations, and an interlock among some of them and certain intermediary organizations, have exercised a strong effect upon our foreign policy and public education in things international. This has been accomplished by vast propaganda by supplying executives and advisors to government and by controlling much research in this area through the power of the purse. The net result of these combined efforts has been to promote "internationalism" in a particular sense - a form directed toward 'world government' and a derogation of American "nationalism."*⁴¹

Goals – World Government

Like Nimrod of old, today we are reassembling the nations again in humanistic defiance to God.

First - The world political system is unifying through the United Nations (One-World Government).

Second – With UN assistance, the leaders of the various religions are attempting to unify the major religions of the world (One-World Religion).

Third - The world's money powers are attempting to remake the world's economic systems (Global Economy).

Fourth - The world's intellectual establishment is attempting to mold the

minds of the world's citizens into a global allegiance (Anti-Nationalism; Anti-Patriotism; Globalism).

Together these are termed the **New World Order**.

Further, the religious differences must be abridged and reconciled into a form of New World Religion. New Age Eastern Religion (Babylonian Mystery Religion) established through religious cooperation and reconciliation through environmental issues (Earth [Gaia] worship). Man's intention is to build a "New World Order," for himself.

Today we hear more and more that in order to achieve world peace all nations must become "democracies." This is another name for achieving a political New World Order, where the entire world can be as one – just like Nimrod's scheme, the world is building its new Tower of Babel. Physically it is symbolized by the United Nations in New York City, the European Union (EU) in Europe, the North American Free Trade Agreement (NAFTA) in the Americas, the Central American Free Trade Agreement (CAFTA) in Central America, and other regional alliances. It is called the New World Order. One stated benefit of CAFTA is that it will help encourage democratization of Central American countries. The problem is that it will shift manufacturing jobs from the United States to Central America in a massive foreign aid scheme.

To accomplish this new world order, Americans will be asked to relinquish sovereignty – probably very slowly, so we won't notice – Europeans rejected a constitution in 2005 because of this issue. This may well be accomplished by the decay of our culture through a managed crisis. How is a managed crisis orchestrated?

Dialectics

***How's I s'posed to know what to say
less'n you tells me how to think?***

Pogo⁴²

Control of media

If you are in a position to control the media, you can manage the news and influence what people are allowed to hear. The media, both print and electronic, is controlled by only a very few organizations. The heads of these organizations belong to the same secret insider organizations that we have discussed. These media heads subscribe and support the same goals of new world order/world

government. In effect, the media dispenses propoganda to further their goals.

Propaganda

From Scripture we know that there will be many deceptions of false prophets in the world, and in the end times – a great delusion sent by God (Matthew 24:24; 2 Thessanionians 2:11).

World leaders manage men's minds by propoganda. Notice this quote from a well known newspaper editor: "I'm interested in causes. *We don't print the truth.* We don't pretend to print the truth. We print what people tell us. It's up to the public to decide what is true."⁴³

Remember that Nimrod said in Genesis 11:4, "let us make us a name." "Let us make a name" is central to the man-centered religion of Humanism. They say: "Give man the glory, we have accomplished this great thing." Man is attempting to share the glory of God. The Tower of Babel was erected for the glory of man. Man is defying God. He is saying that he is self sufficient – he can do without God. This is "humanism." It is defiance of God's command to "Be fruitful, and multiply, and replenish the earth" (Genesis 9:1)

Changing Perceptions

The moneychangers and the Secular Humanists today work diligently to change the way people think and how they view the world. They wish to eliminate God and create a secular society. In doing so, the Christian is made to appear ignorant and bigoted. And, for the most part, the Christian remains complacent as the Christian worldview is overthrown.

And they said, Go to, let us build us a city and a tower, whose top may reach unto heaven; and **let us make us a name**, lest we be scattered abroad upon the face of the whole earth. **Genesis 11:4**

To establish a world-empire Nimrod needed a city, or headquarters, to bring unity to the people; and he also needed a motive to inspire and encourage his followers ("let us make us a name"). Many leaders act in the same manner. We are deceived as to the actual goals while we are given "carrots" (propaganda) to motivate us in the direction they want us to go.

Our histories have likewise been tampered with towards that end. Much of the "official" history of the world has been rewritten to suit the political worldview of the time or of the author. The victors

(those in charge) always get to write the history. For a revelation of this see Catherine Millard's book, *The Rewriting Of America's History*. This book is a detailed account of how our American history is being slanted to remove or denigrate our Christian foundation. It includes excerpts from textbooks, and other historical documents that show how American history is distorted in the public arena and schools. To the modern historian and teacher, relative truth replaces absolute truth in meeting agenda goals.⁴⁴

Our histories have been watered down and sugar coated to preserve the power structure that man has erected. Often that history is reflective of the agendas and ideology of those people in charge. Generally speaking, people do not understand what the issues and problems are all about. They only imagine that they understand based on the acceptance of the propaganda machines of the media and the pronouncements of our various leaders, both liberal and conservative. News is strung together in sound bites and given a particular slant for a managed agenda.

One way to manage groups, or the populace, to arrive at desired goals, is to foment opposition within each group or nation. The idea is to keep the focus of the citizens on each other, away from the leaders, while the government acts as the benevolent peacemaker. A planned and managed crisis, called dialectics, is used.

Dialectics is implemented by a crisis being created, or taken advantage of, to produce tension in order to get the people to demand relief. The government then offers the preplanned solution, while the people who otherwise would have protested say, "thank you very much." This allows the government to manage changes, without opposition, to fulfill their agenda. Without the World Trade Center attack crisis, the people would have never agreed to the controls contained within the Patriot Act.

According to David Noebel in his book, *Understanding the Times*, dialectics is the clash between opposites. It is a "Progressive process in which the thesis (the status quo) clashes with its antithesis and forms a synthesis, which becomes the new, more advanced thesis."⁴⁵

The disturbance (Antithesis) may be real or manufactured. The disturbance may have been introduced to obtain a planned result (solution). The people without the introduction of the disturbance may have not otherwise accepted the solution. An example of dialectics might be that the threat of global warming with dire consequences may be real or created to indoctrinate people to accept reduction

or elimination of fossil fuels and/or prevent cutting of forests.

The novel *State of Fear* by Michael Crichton is footnoted with examples of scientific studies that seem to say that global warming is not the crisis that it is made out to be – instead, the evidence seems to point to global warming being cyclical, or local.⁴⁶ Whether or not the premise of the book, that global warming is not real, is true or not is not important to our discussion. What does matter is that many crisis situations are used to further political agendas. In fact, *State of Fear* may itself be propaganda to further a personal or political agenda.

Dialectics identifies the problem as: Antithesis = (Opposite) {Disturbance} Thing, Idea, or Situation that produces tension. The tension continues until the people accept the "solution," at which time synthesis (status quo) is reached, producing the new thesis. No new tension (antithesis) is introduced in opposition to the new thesis until change is desired.

Another example of how dialectics works is illustrated by the following: If denying the right to gun ownership is the politically desired result, then the media and government would focus their efforts on the evils of gun ownership and need for gun control, producing a national debate, causing tension. If the tension is great enough, and the propaganda effective, then the people will demand and accept the pre-planned solution, loss of right to gun ownership.

Changes in worldviews (how people perceive their world) are brought about by dialectics.

Truth

Worldviews can also be thought of as how we view truth and where truth comes from. Worldviews based on how we view truth are:

1. Pre-modernism
2. Modernism
3. Post-modernism⁴⁷

To understand what is driving the world today, we need to understand how people in today's society view truth. In reality, the concept of truth has been subjected to the ideas of evolution.

Pre-modernism

Pre-Modernism can be described as the dominant worldview from the beginning until the enlightenment (18th century).

It believed that there is truth and it comes from God. Truth has a supernatural source, and men believed that it was found in their religion; whether Christian or pagan – your religion defined

your truth. The Christian believes that truth is found in the Word of God.⁴⁸

Modernism

Modernism would say that there is truth. We can know the truth through human reason, not through the supernatural, not through a revelation from God, and it cannot be found in the Bible. Science is the key – we can know truth through science and philosophy. This worldview lasted about 250 years from the 18th century until well into the 20th century, until the collapse of communism.⁴⁹

This worldview brought about godless totalitarian governments because men thought they knew the truth and therefore dictated the truth through dictatorial regimes. During this period we saw fascism, Nazism, and communism – And the genocide of millions of people. We also saw the rise of Darwinism in 1859. Shortly after that we saw evolutionary principles applied to our system of laws. This occurred when our legal system was changed from Blackstone's law, based on biblical principles, to "Case" law, based on the evolution of law through precedence. Thus this new legal system is based not on whether it is morally right in the eyes of God, but on evolving laws based on evolving morality and culture.⁵⁰

Post-modernism

We are now living in the post-modern world. This worldview says that there may be truth, but we can not be sure of the truth. Truth may be from God, but we can't know it. Post-modernism embraces mystery – we can't know the truth. My truth is my truth and your truth is your truth. Everyone has his own truth – truth is relative. Since we can't know the truth we must be tolerant of the beliefs of others – "This is who I am, and how I live; you must accept me the way I am." Truth is whatever you think it is. Truth is not universal. Truth is experiential. Therefore the virtues of this worldview are tolerance, ambiguity, and mystery. There are no absolutes and therefore we cannot know what is right or wrong. We can't know what the Bible means. Man can now invent whatever religion he wants, without challenge. The modern Emerging Church movement has embraced this idea – It's okay to be homosexual; it's who you are.⁵¹

Consider what Aldous Huxley wrote about what he saw as the emerging world order in *Brave New World Revisited*:

... children are nowhere taught, in any systematic way, to distinguish true from false, or meaningful from meaningless, statements. Why is this so? Because their

*elders, even in the democratic countries, do not want them to be given this kind of education.*⁵²

Huxley understood that the government's tendency is to manipulate the minds of its citizens into complying with their system and goals:

*In its present form, the social order depends for its continued existence on the acceptance, without too many embarrassing questions, of the propaganda put forth by those in authority and the propaganda hallowed by the local tradition.*⁵³

To this end Huxley indicates that the public must be "suggestible enough to be willing and able to make their society work."⁵⁴ This is done through education and propaganda manipulation. Huxley says that **we** must, as parents, educate our children for freedom and self-government,⁵⁵ the original intention of our founding fathers. According to Bruce N. Shortt in *The Harsh Truth About Public Schools*, this may mean home schooling, Bible based schools, or at least closely monitoring what our children are being taught.⁵⁶

There are a number of other philosophical beliefs that affect our society today. We will look at two.

Pragmatism

Progressivism is an idea held by many individuals in the early years of the 20th century. It was a belief that "progress could be achieved by the aggressive use of government power." The ideas of progressivism fueled Franklin Roosevelt's New Deal of the 1930's. The form it then took "came to be called Liberalism, a considerable distortion of an older set of ideas once known by that name."⁵⁷

The cornerstone of modern Liberalism is personal liberty — permissiveness within legal bounds. The modern liberal has infused another philosophy within their ideology designed to make socialism acceptable to the masses. This philosophy is known as Pragmatism. It is a philosophy built on never-ending evolution. As pragmatists, they promote the idea of "continuous and ongoing reform." To them everything is in flux, nothing is fixed, and therefore it is "possible to reshape man and the world about us according to our [the liberals] wills."⁵⁸ The ideas of Progressivism (Liberalism) when infused with the philosophy of Pragmatism gave impetus to the push for continuous social transformation, where the country could embrace socialism, a little at a time, without ever realizing they had been infected (gradualism).⁵⁹ This is what has been taking place in our society.

Deconstructionism

Historian Anne Harrington indicates that “deconstructionism” and “logocentrism” are “key words” of post-modernism, and “had their origins in antiscience tracts written by Nazi and protofascist writers like Ernst Krieck and Ludwig Klages.”⁶⁰ Logocentrism is the tendency to give more value to the words than to the meaning of the words.⁶¹

Jonah Goldberg, in his book *Liberal Fascism*, defines “deconstructionism” as follows:

*Deconstruction – a literary theory which holds that there is no single meaning to any text – caught fire in the minds of academics and students alike who hoped to be liberated from the dead weight of history and accumulated knowledge. If all texts were diversely interpretable with no “true” meaning at their core, then the important thing – the **only** thing really – was the meaning the reader **imposed** upon the text. The right interpretation is the one held by the interpreter who “wins” the academic power struggle.*⁶²

History therefore has no meaning other than the current interpretation placed upon it. To the world planners, history is a tool to be manipulated to change society. Manipulation of the mind can take the form of a perceived threat such as war.

The Political and Economic Usefulness of War or the Threat of Disaster

War and Disaster

We have discussed the various belief systems and methods used to manipulate and control society. Now we are ready to look at the actual benefits that war or other threats have for government and the moneychangers. War is described in the book of Revelation as follows:

And when he had opened the second seal, I heard the second beast say, Come and see. And there went out another horse that was red: and power was given to him that sat thereon to **take peace from the earth, and that they should kill one another:** and there was given unto him a great sword.
Revelation 6:3, 4

This verse refers to the second of the “Four Horsemen,” of which the first brings deception and the third and fourth bring unprecedented pestilence, famine, and death to the world. We have seen how

deception is perpetrated; now we will see war and disaster, after which pestilence, famine, and death always follow.

Iron Mountain

Leonard C. Lewin wrote in the introduction to a government study called *Report from Iron Mountain on the Possibility and Desirability of Peace: Why is war so wonderful? Because it creates artificial demand... the only kind of artificial demand, moreover, that does not raise any political issues: War and only war, solves the problem of inventory.*⁶³

Artificial demand and depletion of inventory creates high profits for the moneychangers. War depletes inventory and creates the demand for more. The report itself states:

*The organization of a society for the possibility of war is [a nations] principal political stabilizer.*⁶⁴

While war in the short-term offers stability, the threat of war provides a more long-term benefit. Opposition to actual war increases the longer it is maintained. The threat of war can be sustained much longer. However, actual war depletes inventory. If peace is preferred to war, then a new threat must be found, and it must be wasteful. A financial collapse and the resulting “stimulus package” to revive it is wasteful and will result in a consolidation of banking and industry into the hands of the powerful few, followed by an inflationary cycle that will devastate many, particularly the middle class, and large financial and power gains for the moneychangers.

According to the report, the definition of “peace” is stated as follows:

*The word peace... [is] a ... condition entirely free from ... contemplation, of any form of the organized social violence, or threat of violence, generally known as war. It implies total and general disarmament.*⁶⁵

The *Report from Iron Mountain* was looking at the possibility of peace by finding a substitute for the **benefits** of war. This “peace” scenario implies that independent nations will no longer have the capability to wage war. A world army called “peace keepers” will keep peace. This is the gist of the U.S. State Department document called *Freedom From War* (State Department document 7277), presented to the United Nations General Assembly by President Kennedy, on 25 September 1961, in which the United States, in a three phase program, would reduce its war making capability, in concert with the Soviet

Union, while at the same time strengthening the “peace keeping” capability of the United Nations.⁶⁶

This document was superseded, in April of 1962, by another disarmament document entitled *Blueprint For The Peace Race: Outline Of Basic Provisions Of A Treaty On General And Complete Disarmament In A Peaceful World*. Like *Freedom From War*, this document also calls for strengthening of the UN Peace Force, “until it had sufficient armed forces and armaments so that no state could challenge it.”⁶⁷

In 1967, the government study called *Report from Iron Mountain on the Possibility and Desirability of Peace* was leaked to the press. The government immediately attempted to deny it by saying that it was a hoax. However, none other than the respected economist John Kenneth Galbraith validated the report by stating that he had been invited to participate.⁶⁸

The purpose of the study was to explore ways to “stabilize society” if war, or the threat of war, is removed as an option. This may prove necessary if nation states are dissolved in favor of a world government. The study examined ways that a government can preserve and perpetuate itself in power, and to control its citizens and prevent them from rebelling.⁶⁹

The conclusions drawn from the report are that a substitute for war in a peaceful society must:

- (1) be economically wasteful (solves the problem of inventory and provides steady employment for the masses),
- (2) represent a credible threat of great magnitude (focuses public attention away from government, allowing willing acceptance of government imposition of restrictive controls), and
- (3) provide a logical excuse for compulsory government service (a type of slavery that controls rebellious, undesirable elements of society, e.g. military service).⁷⁰

Note carefully how, according to the report, the government views its citizens as described in the following:

*The arbitrary nature of war expenditures and other military activities make them ideally suited to **control the essential class relationships** [necessary class relationships, i.e. management, skilled, and unskilled workers]. Obviously, if the war system were to be discarded, new political machinery would be needed at once to serve this vital subfunction.⁷¹*

Until it is developed, the continuance of the war system must be assured, if for no other

reason, among others, than to preserve whatever quality and degree of poverty a society requires as an incentive, as well as to maintain the stability of its internal organization of power....⁷²

*The permanent possibility of war is the **foundation for stable government**; it supplies the basis for general acceptance of political authority. It has enabled societies to **maintain necessary class distinctions** and has ensured the **subordination of the citizen to the state....⁷³***

*No modern political ruling group has successfully controlled its constituency after failing to sustain the **continuing credibility of an external threat of war.**⁷⁴*

According to the *Report from Iron Mountain*, if a nation did not have the threat of war, a substitute would have to be found to replace it. Replacements such as the threat from space by UFO’s or meteorites (whether true or not), or the threat of environmental destruction are among the possibilities seriously considered. During the post-World War II era, the “Cold War” and the possibility of nuclear holocaust provided the necessary threat.⁷⁵ Today we have the threats of global warming, energy source depletion, the threat of terrorist’s attacks, the war in Iraq and Afghanistan, and a failing economy to control the citizens.

The following excerpt from the Report indicates that the threat must be believable to be effective. Keep in mind that the threat need not be real.

*Credibility is the key. Whether the substitute is ritual in nature or functionally substantive, unless it provides a believable life-and-death threat it will not serve the **socially organizing function** of war. The existence of an accepted external menace, then, is essential to **social cohesiveness** as well as to the **acceptance of political authority**. The menace **must be believable**, it must be of a magnitude consistent with the complexity of the society threatened, and it must appear, at least to **affect the entire society.**⁷⁶*

The war on terror and the environment are ideally suited for this purpose

A New Enemy

In 1991, the Club of Rome acknowledged that it was searching for a new enemy to unite us when they made the following statement:

*In searching for a new enemy to unite us, we came up with the idea that **pollution, the threat of global warming, water shortages, famine and the like would fit the bill**.... All these dangers are caused by human intervention.... The real enemy, then, is **humanity itself**.*⁷⁷

Al Gore is saying essentially the same thing.

According to the *Report from Iron Mountain*, we should keep in mind that a substitute for war must be wasteful; it must consume a share of the gross national product. It is therefore significant that President Lyndon Johnson began his massive and costly "War on Poverty" during the height of the Vietnam War. The significance of this is reinforced if we realize that increases in social welfare expenditures are considered to be a possible substitute for war, necessary to fill the vacuum created by the disappearance of military spending.⁷⁸

According to Jasper, in his book *Global Tyranny... Step By Step*, many who have studied the problem believe that the "*repeated prophecies of apocalyptic doom have far more to do with **increasing and centralizing government control over mankind** than with protecting man and nature from environmentally harmful practices.*"⁷⁹

In fact, the "environmental movement" is a major excuse of the one-worlders in bringing about world government. This can be seen in the statements of the influential Worldwatch Institute⁸⁰ head Lester R. Brown in his 1972 book, *World Without Borders*, in which he proposed a:

*... **world environmental agency** [because] [a]rrresting the deterioration of the environment does not seem possible within the existing framework of **independent nation-states**. Once the necessary information and analysis is complete, **tolerance levels can be established and translated into the necessary regulations of human activity**.... Building an environmentally sustainable future... [This would involve] **restructuring the global economy, dramatically changing human reproductive behavior and altering values and lifestyles**.*⁸¹

In Worldwatch Institute's *State of the World* 1991, Brown predicted that:

*[T]he battle to save the planet will replace the battle over ideology as the organizing theme of **the new world order**. [And, with] the end of the ideological conflict that dominated a generation of international affairs, **a new world order, shaped by a***

*new agenda, will emerge... [that will] be more ecological than ideological.*⁸²

The enemy has changed according to an article by political insider, George F. Kennan, appearing in the establishment's *Washington Post*, on 12 November 1989, in which he says that:

*[We now live] in an age where the enemy is not the Soviet Union but **the rapid deterioration of our planet as a supporting structure for civilized life**.*⁸³

The *Report from Iron Mountain* indicated that all proposed substitutes (enemies) for war were inadequate except possibly "the environmental-pollution model."

*In this respect, the **possible substitute enemies** noted earlier would be **insufficient**. One exception might be the **environmental-pollution model**, if the danger to society it posed was genuinely imminent.*⁸⁴

The problem of the external threat is solved in Orwell's book, *1984*, by maintaining a perpetual state of war and shifting alliances. The war [or environmental-pollution threat] did not have to actually exist to be effective, only that the population believed that it existed.⁸⁵ An unending war on terror with undefined and shifting enemies would serve the same purpose.

Do Not Be Deceived

And he [Antichrist] causeth all, both small and great, rich and poor, free and bond, **to receive a mark** in their right hand, or in their foreheads: And **that no man might buy or sell, save he that had the mark**, or the name of the beast, or the number of his name. Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six.

Revelation 13:16-18

The current economic crisis might be just the catalyst that brings the world leader called the Antichrist. Do not take the mark! Do not be deceived. There will be an account that will come due in the not too distant future.

Be not deceived; God is not mocked: **for whatsoever a man soweth, that shall he also reap**. For he that soweth to his **flesh** shall of the flesh **reap corruption**; but he

that soweth to the Spirit shall of the Spirit reap life everlasting. Galatians 6:7-8

We should not fear the things we see happening in this world today, since we have been warned that these things would come in the last days.

And fear not them which kill the body, but are not able to kill the soul: but rather **fear him which is able to destroy both soul and body in hell. Matthew 10:28**

Be sure that you are fearful of the right things. If you have not accepted Christ, then you should fear to die to receive the penalty of your sins. If you are in Christ, then you should not be fearful to die, since you die to eternal life because He, Christ Jesus, paid the penalty of your sins.

But **God**, who is rich in mercy, for his great love wherewith he **loved us**, Even **when we were dead in sins, hath quickened us together with Christ**, (by grace ye are saved;) And hath **raised us up together, and made us sit together in heavenly places in Christ Jesus**: That in the ages to come he might shew the exceeding riches of his grace in his kindness toward us **through Christ Jesus. For by grace are ye saved through faith; and that not of yourselves: it is the gift of God: Not of works, lest any man should boast. Ephesians 2:4-9**

Accept Christ today by faith of what Jesus has done on our behalf and receive eternal life. **ΑΩ**
